## LOCATION

- Lindi is amongst 31 regions forming the United Republic of Tanzania.
- It is situated in South-East of Tanzania between latitude 9- 10.5° South and longitude 38.5-40° East. Approximately 460 Kilometers (286 mi), by road, south of Dar Es Salaam. Furthermore, it is about 103 Kilometers (64 mi), by road, north-west of Mtwara the nearest large
- The region shares borders with Coast Region to the North, Morogoro to the North West and West, Ruvuma region to the West and Mtwara region to the South while the Indian Ocean lies on the East enjoying 285-kilometre coastline offering significant scope for tourism and fishing activities.

# HOW TO REACH IN LINDI

# TRAVEL BY ROAD

Recent infrastructure improvements including completion of the tarmac road from Dar Es Salaam through Lindi to Mtwara - Masasi and Mtambaswala (border town with Mozambique) making Lindi accessible throughout the rainy season.

It takes 5 – 7 Hours when travelling by car 460 Km from Dar Es Salaam.



# **AIR TRAVEL**

It takes about 90 Minutes to travel by Air from Dar Es Salaam International Airport to Mtwara 60 Minutes when travelling by car 105km from Mtwara Airport to Lindi. Also, there is an Airport in Lindi when using charter planes which takes about 45 – 60 Minutes from Dar Es Salaam International Airport.



# DESCRIPTION OF THE LAND SECURED FOR DEVELOPMENT OF LNG PLANT IN LINDI- ii

- The Government thrugh Tanzania Petrolium Development Corporation (TPDC) have secured the land purposely for the construction of the LNG processing
- The area used to be the sisal estate and its title deed was revoked by the Government in Oktober 2015 to pave the way for the new coming LNG plant. The site is at Kikwetu area in Likong'o and Mto mkavu "Mitaa" in Mbanja Ward of Lindi Municipality.
- The area cover 2071.705 Ha. Sq. with an estimated initial capital amounting 30 Billion US Dollars.
- In June 2020 the Government through TPDC completed payment of compensations of all asserts found/developed by former residents who used to live and earn their daily income. For that the area is in process of handing it to investors/developers.

# THE FERTLIZER (UREA) INDUSTRY IS UNDERWAY


- The project will use/depend on LNG as raw materials.
- The area has been secured at Kilwa Masoko and all properties fund there in has been compensated accordingly.
- The initial capital is expected to reach 2 billion US Dollars and investors will be the Government through TPDC in collaboration with private Companies.
- The production capacity per day is expected to reach 2,200 Tons of Ammonium and 3,850 Tons of Urea respectively.

#### **OPPORTUNITIES RELATED TO TOURISM.**

#### Selous Game Reserve (SGR)/Kilwa Tourism Circuit



- Following upgrading of Selous Game Reserve into Nyerere National Park (30,893 Sq.)
- The (95%) of remaining portion of Selous GR to be managed by TAWA (Kingupira and Miguruwe), which has a total size of 18,971 Km<sup>2</sup> is in Lindi Region
- Out of 10 Hunting Blocks which have remained, Five (5) of these blocks are already earmarked for "special concession allocation", while the rest will also be hunted under normal block allocation arrangements.
- □ SGR will also be linked to the strategically located Ruins of Kilwa Kisiwani and Songo Mnara (a World Heritage Cultural Site) that has just been handled over to TAWA management so as to boost its tourism profile.



# ENABLING FACTORS FOR CONSTRUCTION OF MANUFACTURING INDUSTRIES TO CATER FOR AGRICULTURE, MININD AND LNG PRODUCTS.

#### CONSTRUCTION OF STAFF/RESIDENTIAL HOUSES



It is expected that NSSF being in possession of 303 and Watumishi Housing possessing 100 plots in Lindi might start to develop and construct houses to accommodate the expected increased number of both Government and private employees in Lindi region.


